**AMENDED ORDER  
(Motion for Approval of Fees for March to December, 2017)**

2. **THIS COURT ORDERS** that the invoices of the Appointed Actuaries for activity performed during the Actuary Relevant Months (attached to the Hall Affidavit as exhibits L, M, N, O, P, Q, R, S, T, U, V, W, X, Y, Z, AA, BB and CC) totalling \$200,512.22, are reasonable and are approved.”
