

**ORDER
APPROVAL OF FEES AND DISBURSEMENTS**

THIS MOTION, made by Thornton Grout Finnigan LLP (“TGF”) pursuant to the *Mutual Property and Casualty Insurance Company with Non-Mutual Policyholders Conversion Regulations*, SOR/2015-168 (the “*Conversion Regulations*”), for the approval of fees relating to the period of June 1, 2017 to September 30, 2017 was heard in writing at 330 University Avenue, Toronto, Ontario.

ON READING the Notice of Motion herein, the Affidavit of John Porter sworn on October 31, 2017, the Factum of TGF in support of the motion and on being advised that the Economical Mutual Insurance Company does not oppose the approval of TGF’s fees and expenses for the period June 1, 2017 to September 30, 2017 ;
