
**ORDER
APPROVAL OF FEES AND DISBURSEMENTS**

THIS MOTION, made by Thornton Grout Finnigan LLP (“TGF”) pursuant to the *Mutual Property and Casualty Insurance Company with Non-Mutual Policyholders Conversion Regulations*, SOR/2015-168, for the approval of fees relating to the period of October 1, 2017 to December 31, 2017 was heard in writing at 330 University Avenue, Toronto, Ontario.

ON READING the Notice of Motion herein, the Affidavit of John Porter sworn on February 1, 2018, the Factum of TGF in support of the motion and on being advised that the Economical Mutual Insurance Company does not oppose the relief sought;

THIS COURT ORDERS that the fees and disbursements of TGF, being \$364,586.24 in legal fees, \$129,807.44 in disbursements and other charges, and \$64,250.38 in Harmonized Sales Tax (“HST”), totaling \$558,644.06 are approved.

THIS COURT ORDERS that paragraph 1 of the Order of this Court dated February 22, 2017 be amended to remove William Paul McCrossan as an appointed member of the Non-Mutual Policyholders Committee effective as of the date of his resignation, January 23, 2018.
