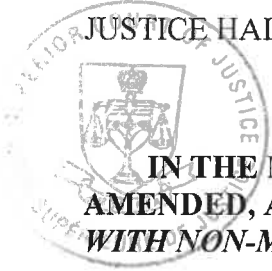



APPROVAL OF SUPPLEMENTAL FEES AND DISBURSEMENTS**

THIS MOTION, made by Thornton Grout Finnigan LLP (“TGF”) pursuant to the *Mutual Property and Casualty Insurance Company with Non-Mutual Policyholders Conversion Regulations*, SOR/2015-168 (the “*Conversion Regulations*”), was heard this day at 330 University Avenue, Toronto, Ontario.
