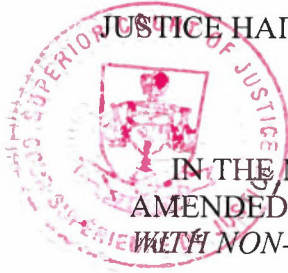


ORDER
